

GROSSI DANCE & PERFORMING ARTS ACADEMY REGISTRANT INFORMATION 2023-2024

TUITION

- *Tuition is seasonally based*; payable in **full year** (3% discount given if paid by September 11th), **semester** (9/1,12/1,3/1), or **ten (10) monthly payments** with the first and last installments paid upon registration (last installment is *non-refundable* if student does not complete the entire dance season).
- **Installment payments are due by the 1st class of the installment payment month and are considered late after the 10th of the installment payment month.**
- Late fee of \$10.00 will be assessed for tuition payments not remitted by the 10th of the installment payment month.
- Registration Fee - \$30/New Student \$25/Returning Student
- Rates - multiple class and family discount rates are available, please see registrar for rate schedule.
- **Refunds and pro rated tuition** are not given, student class changes must be made in writing or by email to the office before the monthly tuition is charged.
- Payments please use the mail box located in the hall outside of the double doors or the tuition mailbox inside the lobby.
 - Checks - payable to Grossi Dance and Performing Arts Academy (GDPA), BANK DRAFTS ARE PREFERRED students name on memo line. Your cancelled check will be your receipt
 - Cash - please place cash in envelope with students name written on the outside and place in the mailbox in the hall outside our double door, or in the tuition mailbox inside the lobby, a cash receipt will be written and returned to you.
 - Venmo - Linda-Regulbuto (first time payers, code is 4311) our studio logo will show.

CLASS PLACEMENT, CONDUCT AND DRESS CODE

- Dance experience, history and ability of the dancer will be the determining factor for class placement, age is a guideline only.
- Students should arrive in a timely manner, in proper attire, prepared to participate in class.
- Students should wait to enter the classroom until instructor arrives and conduct themselves in a respectful manner towards all.
- Attire - **Proper attire is mandatory**, please consult website: www.grossidanceacademy.com or instructor for class attire, hair and dance shoe requirements.

SHOWCASE

- Showcase dates and information are generally posted in February
- **Costume deposits of \$50/per class/student must be paid in full by Oct 10, 2023.**
 - Costumes cannot be ordered until costume deposit is paid and account is current.
 - Costume balances are due by Feb 10, 2024
 - **Costumes are non-returnable and non-refundable.**
- Tickets go on sale at the studio the May 13, 2024
 - Mandatory dress rehearsal/showcase insurance fee of \$50/family (includes pass for one accompanying adult at dress rehearsal) is due with costume deposits by Oct 10, 2023. *This fee is non-refundable once costuming has been ordered for the student.*
 - Tickets are required for each person attending but may not be purchased until account is paid in full.
